**WAIVER and RELEASE of**  
**LIABILITY and INDEMNIFICATION AGREEMENT**

I, the UNDERSIGNED, agree that all activities including, but not limited to, on-court practicing, playing, instruction, off-court field trips, on-site dormitory activities, or other use of the equipment or facilities of Intense Tennis Camps ("Camps") are undertaken at the sole risk of the camper/participant. Camper/participant hereby agrees to release and forever discharge Camps, it's operators, agents, servants, employees, consultants, advisors, owners, and lessors for injury or damage to the camper's person or property arising out of, or in connection with the use of the premises or it's equipment including, but not limited to, on-court practicing, playing, instruction, off-court activities, field trips, and on-site dormitory activities, from all acts of the active or passive negligence on the part of such cooperation, servants, associates or employees.

The UNDERSIGNED further expressly agrees that the foregoing Waiver and Release of Liability Indemnification Agreement is intended to be as broad and inclusive as is permitted by the law of the Commonwealth of Pennsylvania in which the activities are conducted and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full force and effect.

My child has had a recent physical examination, is free from infectious diseases, and is physically able to participate in all Camps activities. I realize injuries can be a consequence of participation in this strenuous activity (Camps) and no amount of reasonable supervision, controlled use of the "as is" conditions of facilities, maintenance of a sanitary, healthful, and safe environment, and avoidance of possible negligence, will wholly prevent injury. I have carefully considered how the possible consequence of injury may impact my child's life and I choose to accept this risk and allow him/her to participate in Camps activities.

In accepting this risk, I expressly and explicitly release, discharge and waive any and all responsibility of Camps staff, Slippery Rock University of PA, SSHE, the Commonwealth of PA, and the employees, officials or agents of any and all of the foregoing, pursuant to, or pertaining to, or arising from, in any manner, injuries to my child as a result of his/her participation in this Tennis Camp and it's activities. I further understand I am not entitled to any financial refund after Camps has commenced.

I hereby give consent to Camps to use my name, photo, picture likeness, and/or biographical materials for the promotion of Camps and/or any of its programs and activities, including use on [www.IntenseTennisCamps.com](http://www.IntenseTennisCamps.com) and [www.sru.edu](http://www.sru.edu). I hereby release and agree to hold harmless Camps from and all claims which I, my heirs, executors, and assigns, may have on account of the use of any photographs, videos, or any other media generated as a result of my participating in Camps.
